I needed a car to get to work and transport my daughters back and forth to the baby sitter and to take care of everyday things! Wow! The feeling I got after I got off the phone with him was indescribable,

**One Girl’s Experience in
Foster Care**

At the age of two I was taken away from my mother and forced to live with my aunt along with my five brothers and sisters. We lived in Los Angeles County. We were given a tutor, and had monthly visits from a Social Worker. But once we moved to the San Bernardino County that changed. We lived in two story, 6 bedroom, brand new house. My aunt was not employed, but living off the State money given to her to care for us. We no longer were provided a tutor and the Social Worker stopped coming out for visits. Instead she made monthly phone calls to see how we were all doing. At the time I was 11 years old. In a few years we lost all contact with our social worker.

At age 16, my living condition became worse. At this age, young girls need proper hygiene care, doctor and dentist visits, food, and motherly advice; which I did not get from living with my aunt. I was so unhappy I decided to file with the court to be emancipated at 16 years old. I wrote a letter explaining why I no longer wanted to live with my aunt. In the letter to the court, I mentioned I was not getting the proper care. I never went to the dentist or saw a doctor since I was a child, and the only time I saw a doctor was when I needed to go to the emergency room. My aunt was always gone and left us alone. We never knew where she was or when she was coming back. There was no food in the house, but Ramen Noodles. Things were never replaced like lotion, shampoo, or toothpaste.

To my surprise, a copy of the letter I wrote to my social worker was given to my aunt. She was also told that she would be getting a visit from the state on a certain date. When that day came, I went to school and once I got home my aunt was there and she did some shopping. The pantry was all of a sudden stocked with food; there was lotion, shampoo, and toothpaste. My room was even cleaned. Once the state worker showed up, all six of us kids sat in the living room with my aunt. Of course, I didn't want to talk because of the position I was put in. I couldn't say anything I really wanted to because my aunt was in the same room. A few weeks later my request for emancipation was denied. I remained living there for the next two

years. Things got even worse. When my brothers turned 18, my aunt stopped receiving checks from the State, so she asked them to leave or pay a ridiculous amount of rent when they had no income or jobs. We then moved to a smaller 4 bedroom house. School was never important to my aunt. She didn't care if we went, or didn't, whether our homework was done, or how we were doing in our classes. I fell behind and graduated a year late. Only three out of us 6 children graduated from high school. As soon as I graduated from high school I was out because my aunt was no longer getting State payment for me. Just out of high school, no money, no job, no means of transportation, not even any prior skills or training to get a job. I was lost. Until, I came to Pasadena to live with my older sister. I was on my own now, no one to tell me what to do or where to go. I got myself enrolled in school at Pasadena City College. Somehow I found the County's Independent Living Program in West Los Angeles. They guided me to the Casey Family Program in Pasadena. It was there that I took Life Skill courses and where I was introduced to Jorge from Journey House. Now I'm 20 years old, working and attending school, thanks to Jorge's help, and doing better than I ever have.
